ATTN: WA State Board of Health RE: COVID-19 Treatments July 6, 2021

Dear Board Members:

In August of 2020, Informed Choice WA and nearly 700 of our members filed a petition requesting a forum be provided so that knowledgeable practitioners could exchange existing COVID-19 treatment protocols—that were being marginalized—so that more practitioners and the public could learn about them, outcomes could be improved, and fear dispelled.

Although you agreed such a forum was a good idea and necessary, <u>Secretary Wiesman said it</u> was not in his wheelhouse and that it should be done at the federal level.

It was not done at the federal level and never will be done. The federal government is actively partnering with the pharmaceutical industry to promote new and highly lucrative products and to silence and disparage inexpensive highly effective repurposed drugs, such as ivermectin.

Here we are a year later—with unprecedented numbers of adverse reactions and deaths being reported to the Vaccine Adverse Event Reporting System (VAERS), with breakthrough cases, hospitalizations, and deaths among the fully vaccinated increasing, and the CDC being forced to admit the vaccines do not prevent high-viral load infection and transmission—and still, early treatment with known effective protocols is not the standard of care.

People are still being hospitalized and dying because of the suppression of the effectiveness of early treatment and preventatives such as Vitamin D and ivermectin. Fear is still being fanned, masks being mandated, every aspect of our lives being interrupted. The massive harms caused by this never-ending fear and disruption continue.

Major media and social media platforms are controlled by the medical-pharmaceutical industry and all of the industries profiting highly from the continued fear and disruption. Censorship has reached levels never seen in this free nation before. The Biden Administration even announced they were flagging social media posts they deemed to be "misinformation." Since when is a peer-reviewed published article misinformation? Since when is the testimony of a highly published and experienced doctor misinformation?

If you truly want to end the pandemic, to end the hospitalizations and deaths, to end the disruption of lives, then you must step outside your comfort zones and become active supporters of early treatment with nutrients and repurposed drugs, like ivermectin. You must boldly challenge the FDA and CDC and do what is right for the people of this state.

These are unprecedented times that have revealed just how much change must happen within our captured public health systems. You can be part of that needed change.

Dear Families,

Culver School District was extremely disappointed to learn yesterday that Governor Kate Brown mandated masks for public schools for the upcoming school year. We believe it is our District's role to consider the full impact on safety, learning, and social development that masks have on children.

At our school board meeting last night we confirmed the following:

- 1. Children are medically, physically, and psychologically harmed by mask mandates.
- Masks are a form of discrimination & inequality that is visual, day after day. The students in poverty have to use the school provided medical blue disposable masks, they do not have access to the custom store-bought ones. This visually shows their economic status to everyone.
- No one at the State Level is talking about the psychological effects of masks and communication. We saw negative effects daily on our campus.
- 4. We never had an outbreak of any kind on campus from September to June. Cases that did happen were from exposures outside of school and our parents were excellent at being cautious, informing the school, and keeping their students home if there was even a hint of illness. We trust them to do so again.
- 5. We have an excellent partnership with the Jefferson County Health Department.
- Every decision needs to be given to families and we trust that they determine what they feel is best for their child, both for masks and vaccines.

I will not tolerate any mandate that risks the safety, learning, or social development of our students. Our district will do whatever it takes to retain the stance of local decision making and have masks be optional, honoring each family's wishes for their own student.
