Please allow me to express my concern for our children and students in the handling of the pandemic so far.

CDC data and WA state data clearly shows little to no risk of death or serious illness from a SARS-COV-2 infection for children and teens. As of May 26, the CDC had registered 300 COVID related deaths since 1/1/2020 for the 0-17 age group. Considering that per CDC only about 6% of total COVID related deaths are solely due to COVID and 94% included 1-3 co-morbidities I think it is safe to say that our children and teens have no risk of becoming ill from COVID. Yet our children have suffered the most burden from school closures, suspension of sports programs, isolation from their friends and peers. We may have averted triage in hospitals but now we are facing mental health issues in even our littlest kids.

We are also facing a huge push of COVID vaccinations for our teens. Healthy kids who don't have any risk of harm from COVID are pushed to get vaccinated with a product for which we have limited clinical trial data and NO long term data. A product that is still only approved for emergency use because of the lack of data and testing. STATE COVID REGULATIONS DISCRIMINATE AGAINST LIVE THEATRE

There is no COVID regulatory scenario for fully vaccinated actors to perform under appropriate safety restrictions in the state of Washington. With an audience seated 20'+ from actors, phase 3 still requires on-stage distancing and masks, even outdoors. We request that a fully immunized cast be allowed to work outdoors unmasked, just as they are permitted to meet privately – even indoors – and do all the same things they would do on stage.

Unless action is taken now, thousands of desperately unemployed theatre workers will be prevented from preparing safely staged outdoor productions in time for this summer. Specifically:

1. *The regulations take no account of vaccinations.* Island Stage Left requires all cast and crew to be fully vaccinated before arrival. All of our work takes place outdoors. State regulations ignore guidance for vaccinated individuals, who may socialize freely with each other.

2. *Theatre is treated differently from other businesses.* Unvaccinated restaurant patrons may sit in groups without masks while eating, drinking and talking in an enclosed space surrounded by strangers. Yet fully vaccinated actors cannot rehearse on an outdoor stage without masks. This is unequal treatment. Are indoor restaurants inherently safer than outdoor stages? Are restaurants considered more important businesses than theatres, to be given special treatment?

3. Other performers already work under the conditions theatre needs. Dancers – who breathe much more heavily than actors – may rehearse maskless if their dance requires facial expression or heavy exertion (lifts, tumbles, etc.). Dancers may perform entirely without masks (phase 3 outdoors), and partner dancing dispenses with 6' distancing. Facial expression and body movement are crucial in acting as in dance; and theatre scenes involving romantic partners (or enemy swordsmen) need dispensation from the 6' requirement.

There is a difference, of course: actors speak. This is why we require all cast and crew to be fully vaccinated, and we will maintain 20' between actors and the masked, socially distanced

audience.

Actors outdoors cannot be understood through masks, much less convey the emotions professional acting requires. Microphones costs thousands of dollars to purchase or rent; small professional theatres can't afford them. **The key to all of this lies in one word: vaccination.**

We are very concerned about COVID spread. We follow all rules and recommendations. But when regulations that could <u>safely</u> be loosened are decimating an industry, we need action. If regulations are changed now, there is still time for some theatres to prepare summer performances.

We ask only for this change: no 6' distancing and no masks in performance for a fully vaccinated cast and crew, in phase 3 outdoors. All other regulations strictly enforced.

Please help us bring back live theatre with sensible regulations.

Dear Jennifer Johnson and the Skagit County Board of Health,

I am writing with the interest of advocating for COVID-19 vaccinations to be required in Washington State public schools, the same as other vaccinations are required.

As we have all continued to experience this pandemic unfolding, witnessing the death toll continue to increase has been disheartening. The vaccination plays a huge role in helping to stop continue the spread of COVID-19.

I understand that while the Washington Board of Health (WSBOH) has the sole authority to set immunization requirements for students, this is dependent on the recommendation from the Advisory Committee on Immunization Practices (ACIP) and Food and Drug Administration (FDA) approval of the vaccination itself. However, advocacy coming from individuals such as yourself on behalf of this topic could be beneficial in helping to get a vaccination requirement policy on the table. It could also bring attention to Governor Inslee regarding this issue.

Currently, as you know, the Pfizer-BioNTech vaccine is FDA approved for emergency use in those who are age twelve and older. Because of this emergency approval, it is indicated that this vaccination is extremely important, and warrants being considered required for those over age 12 attending public school. Doing so would contribute to achieving herd immunity and help put an end to this pandemic.

Personally, in my work as a District Nurse for Tukwila School District, as well as my pursuit in higher education to become a Doctor of Nursing Practice Family Nurse Practitioner, I have witnessed the impacts of this pandemic firsthand. Every day I conduct contact tracing, COVID-19 testing, screening/monitoring students for symptoms, notifying and checking in with sick families, etc. Having mandated vaccination, with cases of exceptions, could greatly mitigate COVID transmission in schools and the community as well limit the interruptions in student learning. According to current CDC guidelines, vaccinated students would be able to avoid a 14-day quarantine that causes them to miss out on in person learning if they were to be exposed to the virus at school or in the community and not experiencing symptoms.

As excited as I am that all students will have the opportunity to learn in person full-time again come this fall, I would be much more excited if I knew those who were eligible for vaccination were in fact vaccinated. Washington State Legislature Chapter 246-105 WAC states "Students have the right to attend school without the threat of exposure to certain vaccine preventable disease." It is evident that the COVID-19 vaccination is effective in protecting against infection. Washington State Public Schools would be much safer places for all students come this fall if vaccinations were required for all eligible staff and students.

As a long time, Skagit County resident, and voter, it is important to me that the values of elected officials align with my own. Issues such as this one that not only impact Skagit County and its residents but the state of Washington as a whole and should be considered in the

upcoming WSBOH meeting on May 27, 2021.

I would like to give a comment and implore the board to remove mask mandates from schools.

To share factual information, the California OSHA has said "Cloth face covers are not protective equipment and do not protect the person wearing a cover from COVID-19." (https://dir.ca.gov/dosh/coronavirus/COVID-19-Infection-Prevention-in-Logistics.pdf)

According to the WHO, "One study suggested children between 5 and 11 years old were significantly less protected by mask wearing compared to adults." They've also said that there is an "absence of strong scientific evidence" and they have very limited data on masking children. They also state that the best interest, health and well-being of the child should be prioritized."

Let's discuss what we know about children and the spread of Covid-19. A January 2021 study involving 100,000 students and staff found that 99.98% of children did not get covid from school. There were 32 reported cases of infection (0.032%) and zero instances of a child infecting an adult. (https://www.aappublications.org/news/2021/01/08/covid-north-carolina-schools-study-010821)

Pediatric professors Christele Gras-Le Guej and Regis Hankard, Vice President of the French society of pediatrics and coordinator of Pedstart pediatric clinical research network, respectively, have adamantly stated "Covid-19 is not a pediatric disease. Children must not be subjected to drastic measures, painful to live with, that could disrupt their daily lives, when this microbe really is of little concern to them." (<u>https://up-magazine.info/le-vivant/sciences/65177-la-covid-19-nest-pas-une-maladie-qui-concerne-les-enfants/?</u> login=true)

I could share many more instances where masks have proven unnecessary for children.

Are masks harming children? Yes. A German study done in October 2020 with 30,000 mask wearing children found that 68% of the parents reported the following complaints: irritability, headache, difficulty concentrating, less happiness, reluctance to go to school, malaise, shortness or breath, impaired learning, and drowsiness or fatigue. Accelerated respiration, tightness in chest, weakness, and short-term impairment of consciousness were also reported. (https://www.researchsquare.com/article/rs-124394/v1)

I have personally seen the negative effects of masks on children. I have elected not to send my kindergarten aged son to public school because of the mask mandates, social distancing mandates and complete disregard for the emotional and psychological health of children in the

schools in the state of WA, but we have close friends who have sent their children to school. It has not been an easy season to be an administrator and I regularly pray for our local leaders, teachers, small business owners, pastors, and physicians- that God would give them wisdom and courage in this time. I recognize your efforts to keep children safe, and I know that most leaders are trying to do what they think is best. I want to challenge you to seek truth amongst adversity, and do what is best for the children of Washington.

As a resident, and mother of 2 children, I implore you to remove the mask mandate in schools for our children and their teachers. It is an overreach of power, an assault on our human rights, and a grave danger to our kids. More importantly, it has been proven ineffective as we review a year's worth of data between states and cities that have had mask mandates, lockdowns, etc. versus those that have not. COVID-19 will continue to follow a seasonal curve as it works through various populations, regardless of lockdowns, masking, and business closures. Continuing measures based on feelings and not facts is simply wrong. My children recently returned to in person school 2 months ago, 3 months before school ends for summer. Whether you are in agreement or not, seeing the school mascot painted on the sidewalk every six feet, the masks on all of our children, them separated from their peers was heart wrenching to see. It has been a tough year of understanding, comprehending and absorbing the information the teachers are trying to teach through a screen.

Children have spent almost an entire year with coverings over their faces. They are participating in athletics with masks strapped over their noses and mouths, making it difficult to breath. Children who have been abused, assaulted, and have mental health issues are spending 8 hours a day in masks. They are unable to see each other's faces. They are unable to see the faces of their teachers. Facial expressions are part of our children's development. They are breathing in dangerous amounts of carbon dioxide. There are reports of collapse, lightheadedness, fatigue, and anxiety. We are on the wrong side of history, requiring children to live in masks while claiming they are resilient. It is inhumane. Our children are not resilient!

It's not just the mask, temperature check, health screen, and plastic shield. It's dropping my son at the door, to be questioned by a staff member about his health and demanded to use hand sanitizer before entering the building every single morning. It's a hand washing schedule and the incessant

cleaning of surfaces. It's a painful swab and another quarantine. It's virtual learning, cancelled sports, and a parent free campus. It's masked teachers, distanced desks, and a year without performances, school assembly's, game nights, and proms. It's the appeasement of the local health department and added interventions to meet Washington Education standards. It's a face covering for a hearing impaired, autistic, sexually abused, asthmatic, claustrophobic, or anxious child. It's a filthy cloth mask increasing the incidence of illness and infection in our children. *It's the long term psychosocial effects of not seeing the faces and emotions of other humans for an entire year and counting*. While we do not have all the final data and consequences today, we will read about them in history books.

Cases of abuses and neglect are soaring. Childhood anxiety, depression, and panic attacks are being normalized. We're witnessing record setting childhood suicides- children as young as 9 years old. Self-harm and eating disorders are on the rise. Childhood obesity and diabetes are growing exponentially. Child pornography and the online exploitation of children has spiked. The microbiomes of children are being destroyed, their immune systems weakened. We've broken their trust in 'science' and the understanding of what the word even means. We are witnessing the collapse of the mental health of a generation of children.

In-person learning is the bare minimum. We have so far to go. The so-called cure is exponentially worse than the disease. It is discriminatory and cruel and we are standing by, watching it happen. By accepting this as our "new normal," we set a precedent for our future. I'm not suggesting we throw all caution to the wind. I am highlighting that as we stack measure after measure without a second thought, it's wearing on our kids. *It is time to reevaluate.*

Children are being sacrificed to appease an irrational, fearful society that refuses to see the truth. The virus is real, but the narrative is not. The curve is unbothered by the abuse being done. More importantly, kids aren't driving the pandemic. History books will tell of this crime against humanity- of when we sacrificed a generation of children in the name of 'loving others' all the while ignoring the beloved science. Where are the coalitions and city task forces committed to repairing the physical and mental health of our children? Where are the research studies on the death toll caused by our interventions? The consequences of our complacency will last for years, far outlasting any virus.

COVID-19 is substantially less dangerous to children than the flu. They rarely transmit the virus to adults and most often present mild or asymptomatically. The literature is overflowing with proof that our obsessive, anxiety riddled interventions do not create different outcomes, transmission rates, or mortalities. Anytime I address mandatory masks with the school staff, they tell me they have to follow these rules, that "their hands are tied," due to regulations set forth by OHA and the CDC. This must change. *We need to follow evidence based medicine.*

Although, I commend your efforts to get our children back into the classroom, I am disappointed in your leadership, I'm disappointed that so many agree with me on these issues, yet very few will stand up, push back or even questions these outrageous regulations. There is no evidence that masks are protecting children or teachers. Surface spread is not documented. Temperature checks do not decrease transmission or discover more than a tiny fraction of cases. *These interventions are harmful. Our children need normalcy.* They need to see their teacher's faces. They need to have a

normal Christmas program and perform with their parents in the audience. They need to sit with their desks facing each other. They need to sing and play with their friends at recess.

Please unmask our children. Please stand up for them. Please fight for them. What we are asking them to endure is wrong, and we are responsible if we allow it to continue. I know there are hard decisions to be made. I am praying for you- for wisdom, discernment, and courage as you make decisions and as you seek guidance from local officials. I have contacted them as well. As a concerned mother, and follower of Christ, I feel led to speak up. I will not stop speaking the truth into this issue- it is so important. I would like to give a comment and implore the board to remove mask mandates from schools.

To share factual information, the California OSHA has said "Cloth face covers are not protective equipment and do not protect the person wearing a cover from COVID-19." (https://dir.ca.gov/dosh/coronavirus/COVID-19-Infection-Prevention-in-Logistics.pdf)

According to the WHO, "One study suggested children between 5 and 11 years old were significantly less protected by mask wearing compared to adults." They've also said that there is an "absence of strong scientific evidence" and they have very limited data on masking children. They also state that the best interest, health and well-being of the child should be prioritized."

Let's discuss what we know about children and the spread of Covid-19. A January 2021 study involving 100,000 students and staff found that 99.98% of children did not get covid from school. There were 32 reported cases of infection (0.032%) and zero instances of a child infecting an adult. (https://www.aappublications.org/news/2021/01/08/covid-north-carolina-schools-study-010821)

Pediatric professors Christele Gras-Le Guej and Regis Hankard, Vice President of the French society of pediatrics and coordinator of Pedstart pediatric clinical research network, respectively, have adamantly stated "Covid-19 is not a pediatric disease. Children must not be subjected to drastic measures, painful to live with, that could disrupt their daily lives, when this microbe really is of little concern to them." (<u>https://up-magazine.info/le-vivant/sciences/65177-la-covid-19-nest-pas-une-maladie-qui-concerne-les-enfants/?</u> login=true)

I could share many more instances where masks have proven unnecessary for children.

Are masks harming children? Yes. A German study done in October 2020 with 30,000 mask wearing children found that 68% of the parents reported the following complaints: irritability, headache, difficulty concentrating, less happiness, reluctance to go to school, malaise, shortness or breath, impaired learning, and drowsiness or fatigue. Accelerated respiration, tightness in chest, weakness, and short-term impairment of consciousness were also reported. (https://www.researchsquare.com/article/rs-124394/v1)

I have personally seen the negative effects of masks on children. I have elected not to send my kindergarten aged son to public school because of the mask mandates, social distancing mandates and complete disregard for the emotional and psychological health of children in the

schools in the state of WA, but we have close friends who have sent their children to school. One child, in first grade, is told he is not permitted to drink water in school because he cannot pull his mask down. He is threatened with punishment for playing tag outdoors, while wearing a mask. He comes home with headaches and has said he would rather stay home and not attend public school if he has to keep wearing a mask. This is one example of hundreds of children having negative experiences in the schools due to the lack of regard for emotional health of children.

With the DOH guidelines for the 2021-2022 school year recently being updated, myself and many community members are outraged that the restrictions have not been lifted. States across our nation have banned the use of masks and social distancing in schools, yet the state of Washington continues to disregard the factual information and emotional well being of our children. As public employees, funded by taxpayer dollars, schools and the DOH should be basing decisions regarding children as the highest priority, following what the community is asking for and demonstrating by leaving public schools in droves. This will only continue and exponentially increase if the restrictions are not lifted and the testing guidelines are implemented in schools, per the DOH updated guidelines as of May 13, 2021.

Please, I implore you to consider the mental and emotional well-being of children as the highest priority, with the data and science to prove that the mask mandates are not warranted.

I urge members of the State Board of Health (BOH) to take the step of scheduling a hearing to determine whether Ms. Amelia Clark, SRHD Administrator, is guilty of failing to obey or enforce provisions of RCW 70.05.50. And at that time of that hearing, if the evidence warrants, use your authority to remove Ms. Amelia Clark from her position.

I have reviewed the preliminary findings in the independent report. If there is anything we have learned over the past year, it is that public health competence matters. Lives are lost when health departments are undermined, either from within or from external stakeholders. The report's findings provide evidence that Ms. Clark failed to demonstrate a basic understanding of personnel procedures in her own organization. She put our community at risk when she attempted to terminate Dr. Lutz without due process. Her reckless and inappropriate actions threw our health department into chaos as COVID19 cases were peaking in our region. Ms. Clark's flagrant misconduct created a climate of uncertainty and fear in Spokane, just at a time when we needed competent leaders (such as Dr. Lutz) at the helm.

I urge you to act boldly and thoughtfully within the scope of your authority. When the time comes and if the evidence warrants, remove Amelia Clark from her position. Send a message to our community that public health matters, due process matters, and the lives of people in the Spokane region matter. Thank you for consideration of my input.

Hello. I have been informed that you will be having a meeting on Wednesday. As I will be working and cannot attend, I would like to email you with some concerns that I would have brought up had I been able to speak in person.

First off, I would like to address you as a person who works in a medical field. Although I am at the lower tier of medical fields, I still do go through training. Something that training never taught me was to wear a mask around sick people. I just had a conversation about this with a doctor earlier today. When have we ever been trained that a thin piece of fabric could protect people from deadly viruses? When have we gone into hospitals in the past and saw everyone wearing masks in case others might be contagious? Never because it was always known that it would be illogical. Even Fauci initially publicly scoffed at the idea of masks then did one of many 180s and suddenly masks were mandatory everywhere. I'm writing you with hope that you will read my concerns with regards to making the Covid "vaccine" a requirement for school children.

In the event of injury or death, your only recourse is applying to *the <u>Countermeasures Injury Compensation Program (CICP)</u> for compensation. The statute of limitations is one year.*

Without liability, there's no accountability. Would those working in public health be so eagerly preparing to promote and distribute experimental vaccines if they were responsible for the injuries or deaths caused by those products?

Studies are showing that natural immunity to COVID-19 is long-lasting. <u>A study published In</u> <u>October</u> finds that exposure leads to the development T-cell immunity. As a Washington parent of school-aged children and someone who cares about all children, I am gravely concerned about the recent expansion of the experimental Pfizer COVID-19 injections to children between the ages of 12 and 15. As you know, these fast-tracked shots are not licensed by the FDA, the manufacturers and administrators bear no liability for deaths and injuries, and testing in this age group was limited to fewer than 2300 children for a median of two months. Dear Board of Health Members:

Over the past several years, we have brought to those occupying your seats our concerns regarding the lack of adequate vaccination safety studies and the corporate-capture of the state and federal agencies that are supposed to be protecting us. We have pleaded with you to take action at the state level when guidelines coming down from the federal level put WA citizens at risk. You have never taken action.

On May 12, 2021, the United States Advisory Committee on Immunization Practices (ACIP) revealed their absolute corruption to the world when they cast a vote so dangerously reckless, they put the lives of our nation's children at risk.

Not only did the ACIP vote to recommend the Pfizer investigational Emergency Use Authorization (EUA) Pfizer shot to children ages 12 to 15 in the absence of medical indication and adequate safety studies, but they also voted to end restrictions around co-administration with other vaccines. They freely admitted there has not been a single clinical trial administering any of the shots with any other vaccine. Not even in animals.

What happens when a 12-year-old child is injected with Merck's Gardasil with its highly reactogenic aluminum AAHS adjuvant in one arm and the Pfizer mRNA shot in the other? What happens when the child's cells begin pumping out genetically altered spike protein in the presence of an adjuvant that is revving up their immune system to go on the attack?

ACIP has no idea. Nobody does.

After the public comment period, during which several citizens expressed their grave concerns over authorizing the shots for this age group and their alarm about co-administration, the ACIP added a bullet point to their slide:

"It is unknown whether reactogenecity is increased with coadministration, including with vaccines known to be more reactogenic, such as adjuvanted vaccines."

And then they voted to allow it.

The next morning, the drug industry's insider magazine Fierce Pharma wrote:

"As revenues for several Big Pharma players slumped to start the year, execs blamed part of the problem on the accelerating COVID-19 vaccine rollout. The Centers for Disease Control and Prevention (CDC) had recommended people don't get another shot within two weeks of their COVID-19 vaccine, hitting sales for key products.

Now, the CDC is doing away with that suggestion entirely in an effort to boost routine immunizations among teens. The move could spell financial rewards for leading vaccine companies such as Merck, GlaxoSmithKline and Pfizer."

What was the reaction by the WA State Department of Health to the ACIP vote? Their FAQ page on COVID-19 vaccination now states, "People can now get the COVID-19 vaccine within 14 days of other vaccines, including on the same day."

That's it. No warning, no explaining that safety of co-administration is not known.

This is how our failed public health system operates. Captured agencies make decisions in the best interest of the drug industry, states turn the decisions into blanket statements and policies that falsely imply safety, the information is pushed out to the medical community and the public, and then a mother brings her child to her trusted pediatrician. She is told by the pediatrician—who uses the "presumptive" script taught by the DOH and CDC—that the child is due for several "routine" vaccinations and the Covid shot, and if the mother questions giving them at the same time, she is told that the ACIP now recommends it.

As you read this, a child in this state may be in an office, being injured or killed by the experimental co-administration of a Covid shot with other injections.

Will you take action?

In August of 2020, before any EUA was granted to any of the shots, we petitioned you to convene a committee of knowledgeable frontline practitioners so that existing COVID-19 treatments could be discussed, shared, made known to the medical community and the public, and lives could be saved.

Although you acknowledged the importance of such a committee, you denied our request, saying it was the responsibility of those at the federal level. Almost a year later, people in this state are still dying needlessly because you refused to act.

The federal agencies did not convene a committee and they have been ignoring or denigrating highly effective treatments like ivermectin. Why? Because if they acknowledge or support them, they would have to pull all the EUA's from the shots. They are allowing people to die in order to push their vaccine agenda.

Pfizer and Moderna have now applied for full licensing. Phase III clinical trials have not been completed—and they never will be because they have all been unblinded. Unprecedented numbers of reported adverse reactions and deaths have been reported to VAERS and to every vaccine adverse event reporting system in the world, and yet it is clear the FDA intends to rapidly license the shots, the ACIP will recommend them to children, and manufacturers will move from the liability shield of the PreP Act to the liability shield of the 1986 Act.

Where does that leave WA citizens?

After learning what they have done, do you still have any trust in recommendations coming from the ACIP?

Will you continue to insist that they are experts whose recommendations should be followed? If so, then the board and members of Informed Choice WA have lost what little hope we had remaining in you.

But if you do now understand that we are at a critical juncture of public health history and that drastic changes must be made in order to restore scientific integrity into the public health system, then you could be heroes to every man, woman, and child in this state.

We understand that as a board you are limited in your authority, so we are requesting the following, which fall within your capabilities:

- 1. Through your network of resources at the BOH and DOH, ensure everyone in the state knows there is no safety data behind coadministration.
- 2. Do not consider beginning the rule-making process of adding COVID-19 shots to daycare or school requirements.

Please protect our children.
