

Gardasil has a terrible safety record. Gardasil has an alarming safety record. According to the federal Vaccine Adverse Event Reporting System as of 7/14/2019 there have been 62687 reported adverse incidents with HPV vaccines, including 510 deaths, 15,413 emergency room visits, 6,309 hospitalizations, and 3031 permanent disabilities. And according to Dr. David Kessler, who was the head of the FDA under Presidents George H. W. Bush and Bill Clinton, these injuries are probably less than 10% of the actual number. The safety record for HPV vaccines is so troubling that Japan ended their recommendation of HPV vaccination for Japanese girls in 2014.

Children do not know enough about their own medical history to consent. It is absurd to assume that a child of any age knows enough about their own medical history and the medical history of their family to provide informed consent. They must know if they had earlier adverse reactions to vaccines given to them as infants, whether they have allergies or sensitivities to vaccine ingredients, or if there is a family medical history that would contra-indicate a shot. A nine-year old, or younger, child will know this?

Dear Washington Board of Heath,

I am writing to oppose the addition of the Gardasil HPV vaccine to the childhood vaccine schedule.

First of all, since HPV is a sexually transmitted disease, Gardasil is therefore not appropriate to be recommended or required for school attendance.

Secondly, there is not a HPV health crisis: Contraction of HPV does not always turn into cervical cancer, PAP smears are an effective mode to monitor pre-cancer for those who do have HPV, and Cervical Cancer kills only 2.3/100,000 people annually.

Third, Gardasil kills more people than it potentially saves: According to the Vaccine Adverse Event Reporting System as of December 2019 there have been 63,979 adverse reactions to Gardasil and 523 vaccine related deaths. The death rate of this vaccine during clinical trials as reported by Children's Health Defense was 85/100,000 (37 times that of cervical cancer) showing that not only is it unsafe, but actually more deadly than the disease itself.

In my view, we, the public, need the Washington State Health Department to be discerning when recommending vaccines. I ask that public health officials consider how unhealthy our population has become over the last few decades and tirelessly search for the root cause. According to HHS studies we now have 54% of children with a chronic disease up from 12.8% in the 1990s. Consequently, it can be argued that, the CDC has overseen the greatest health decline in recent history. Our independent state health department must address this, coming to conclusions about this public health crisis independently, instead of relying on the CDC to find the cause. There is evidence that the current bloated vaccine program may be contributing to the increase in chronic disease. Recent worldwide studies on aluminum toxicology and aluminum adjuvents point to vaccines as a potential problem.

I request that the Washington Health Department do their own independent investigation into the safety, efficacy and necessity of each recommended vaccine and ethically and honestly report findings to all the citizens of our state. I am writing to voice my staunch opposition to adding the Gardasil vaccine to the requirements for school entry. The idea is a gross overstep, to say the very least. The role of public health should not extend to the use of coercion to compel uptake of any pharmaceutical product. First, even if driving down the number of cervical cancer deaths in Washington were a compelling state interest, forcing young children to receive HPV vaccinations is unnecessary to achieve that goal. HPV can only be transmitted through sexual intercourse. In addition, it can take decades for an HPV infection to cause cervical cancer, if it ever does. Vaccinating against the virus is therefore not essential to contain an imminent public-health crisis. Second, because sexually transmitted diseases are preventable through lifestyle and behavioral choices that can be taught, injecting pathogens into children's bodies is needless. Third, the HPV vaccine only protects against some strains of the virus. Thus, even with the vaccine, a woman could still contract a strain that can lead to cancer. Most of the time, HPV goes away on it's own, without causing health problems, Only a small percentage of woman whose bodies cannot clear the virus-estimated at about 10 percent-are at risk of developing cervical cancer, and only a fraction of them ever do. Similarly, the contraction of HPV can be prevented through sexual education, use of condoms and premarital abstinence. Regular pap tests are successful at detecting cell changes on the cervix that might become cervical cancer. All of these are effective options that impose no restrictions on parent's constitutional rights to make decisions about the care of their children, a right that the Supreme Court long ago deemed fundamental. Whenever government conduct infringes on a fundamental right, it must pass "strict scrutiny", the most exacting standard of review. Under this standard, the state must establish that the law is necessary to achieve a compelling government purpose, and that it interferes with protected rights no more than necessary. The decision whether to administer this vaccine to a child, regardless of it's efficacy, should be made by that child's parents, not the government, as this mandate does not pass the "strict scrutiny" requirement. 63,979 HPV vaccine-related adverse events

523 HPV vaccine-related deaths

Of those, 650 adverse events and two deaths, in girls aged 11 and 13, occurred in Washington State. Gardasil is covered under the 1986 National Vaccine Injury Compensation Act. They have refused to release just how much they have made despite Freedom of Information Act Requests. When the same government agency that profits from a product is also in charge of promoting that product and monitoring it for safety, there is an irreconcilable conflict of interest.




There is no public health crisis.
