These comments are being submitted to the Washington State Board of Health pertaining to CR-102, Announcement regarding proposed rule, for chapter 246-101 WAC-Notifiable Conditions.

We feel very strongly that Aspergillus contamination and infections has to be listed as a "Notifiable Condition" that healthcare providers/hospitals must report to the DOH/local health agencies. This information also has to be publicly available for patients and families to make informed decisions when seeking treatment at Washington Medical facilities. This type of disclosure would also notify the treating doctors and staff on the risk of exposure to aspergillus while at a hospital.

Our daughter, Hannah Single-Schwall, was a patient at Seattle Children's Hospital from 2003-2005. She suffered a pulmonary hemorrhage in 2003, while at Seattle Children's Hospital, that we feel was directly caused by Aspergillus. Later bronchial lavage and biopsies proved she had Aspergillus, Rhizopus, and Candida. She suffered the entire 20 months she was hospitalized with lung issues and fungal infections. She had to use supplemental oxygen for the rest of her life after the pulmonary hemorrhage. She passed away 2-18-2005. One of the cases of death listed on her death certificate was fungal infections.

Please make changes to list Aspergillus as a "Notifiable Condition". This is very serious and life threatening for many patients. Facilities need to have stricter testing and compliance standards to prevent continued Aspergillus contamination risk due to faulty HVAC Systems. If we had known that there were reported Aspergillus infections and deaths at Seattle Children's Hospital, we would have never taken our daughter there for treatment. She could possibly still be alive today if this information related to Aspergillus was public information when we were researching which hospital to choose for Hannah's lifesaving bone marrow transplant.
