LOCAL BOARD OF HEALTH COMPOSITION RULEMAKING SUMMARY AND TIMELINE

JUNE 2021

Background

The State Board of Health (Board) is considering rulemaking to establish a new chapter of rule to implement Engrossed Second Substitute House Bill (E2SHB) 1152, passed by the Legislature in 2021. The legislation requires the Board to adopt rules for the appointment process of non-elected members of local boards of health.

Purpose

The purpose of this rulemaking is to adopt rules as required of the Board in <u>E2SHB 1152</u>. Among other changes, the legislation creates new requirements for local board of health membership, requiring equal representation by elected and non-elected members. Newly required non-elected members must come from a prescribed list of health care, public health, and community groups. The Board is tasked with adopting rules to establish the appointment process of non-elected members. This process must be in a manner that is fair and unbiased, and which ensures, to the extent possible, a balanced representation of elected and non-elected peoples with a diversity of expertise and experience.

Next Steps

The Board is working to identify interested parties and begin research to understand current composition of local boards of health across Washington state. Staff will send updates to the Board's local board of health composition interested parties list and post updates on the Board's website to outline how our partners and interested parties can provide feedback, submit written commit, or provide testimony at future hearings. A <u>CR-101, Preproposal</u> <u>Statement of Inquiry</u>, was filed on June 9, 2021. Staff anticipate working with interested parties throughout Summer 2021 and begin drafting proposed rules in Fall 2021
