RECENT HAPPENINGS

The Board met in August.

In <u>August</u>, (<u>watch the recording</u>) the Board met in Seattle. Among other things, the Board:

- Heard from <u>Public Health Seattle & King County</u> about their Overdose Prevention and response work (<u>presentation</u>).
- The Board's Health Impact Review team shared a Fiscal Year 2024 update (presentation).
- Heard updates on rulemaking, including <u>Newborn Screening</u> and <u>School Environmental Health and Safety</u>.
- Board Member Paj Nandi and Board staff Ashley Bell shared an update on Pro-Equity Anti-Racism planning (presentation).
- Board staff briefed the Board on <u>Yakima</u> and <u>Cheney</u> Water Recreation Variance Requests. The Board will review the requests at the October 8 Board meeting.
- The Board considered and declined a <u>petition on On-site Sewage</u> <u>Systems Holding Tanks</u>.

The Board's <u>Health Promotion Subcommittee</u> met in September and received updates on rulemaking and various projects. They also previewed upcoming Board meetings and heard an informational briefing on the Washington State Health Assessment and the State Health Improvement Plan.

PEAR Plan-Request for Feedback

The Board is working on our internal practices and creating a Pro-Equity Anti-Racism (PEAR) strategic action plan for the Board moving forward. This action plan infuses equity into our work. It will increase access to our meetings, promote equitable rulemaking, and provide staff with the tools and guidance to center communities in our work.



Right now the plan is in a draft stage, and we are inviting community feedback on it. Feedback can include comments on the plan's feasibility, if the plan is meaningful to communities, or how we can measure success, or any other feedback you have.

We're hoping to have individual conversations with various communities around the state who can provide us focused

feedback on how community access to the work of the Board might (or might not!) be impacted by this plan, in positive and negative ways.

These conversations may qualify for compensation. We will note and use the feedback we receive as much as possible. Whether we can incorporate it or not, we'll still loop back with you to confirm what we heard and what we're doing with what we heard.

We're hoping to schedule a conversation with you in October or early November, if possible. Please contact our Community Engagement Coordinator, <u>Hannah</u>, if you or someone from your team is interested.

SCHOOL RULE PROJECT

In 2024, the Legislature <u>directed the Board</u> (page 492) to review and propose new rules to set minimum health and safety standards for K-12 schools. These rules will also formalize school environmental health and safety inspection procedures. The current school environmental health and safety rules (<u>chapter 246-366</u> <u>WAC</u>) are over 50 years old.

Over one million students attend school in Washington State. These students attend public, charter, and private schools. These rules also impact school staff, parents, and other school visitors. The Board recognizes the importance of the built environment and wants to ensure that children learn, grow, and play in a safe space.

The Board is working closely with approximately 25 technical advisory committee (TAC) members to draft proposed rule language. The TAC members range from local health officers, Department of Health staff, small and large school districts, and parents. The Board and the TAC plan to meet at least eight times from August to December 2024 to develop language.



The Board will work with the Office of the Superintendent of Public Instruction to draft cost estimates to implement the rule. The Board will conduct listening sessions and focus groups to encourage feedback. The Board will also complete an environmental justice assessment of the proposed rules. The Board will submit a report with recommendations to the governor by June 30, 2025.
