Quarterly Community Update

RECENT HAPPENINGS

The Board met in October and November.

In <u>October</u>, (<u>watch the recording</u>) the Board met in Yakima. <u>Among other things</u>, the Board:

- Directed Board staff to initiate rulemaking on <u>per- and</u> <u>polyfluoroalkyl substances (PFAS) standards</u> through <u>WAC 246-290-315</u>.
- Heard updates on the Board's <u>School Environmental</u> <u>Health and Safety Rule Project</u>, <u>Newborn Screening</u> <u>Criteria Review Project</u>, and <u>rulemaking related to the</u> <u>Sanitary Control of Shellfish</u>.
- Heard that staff have completed a <u>Health Impact Review</u> (HIR) on SB 5435 concerning residential rent increases. Senator Trudeau requested the HIR.

In <u>November</u>, (watch the recording) the Board met in Tumwater. Among other things, the Board:

- Heard from <u>Thurston County Public Health & Social Services</u> about their current work, including efforts to address social isolation as a public health crisis.
- Convened a panel on the impacts and efforts to reduce the impacts of per- and polyfluoroalkyl substances (PFAS). The panel consisted of technical experts from the Department of Health and Department of Ecology.
- Declined a petition to amend WAC 246-290-220, Drinking Water Materials and Additives, within the Group A Public Water Supplies rules.

The School Environmental Health and Safety Rule Project (SRP) team held listening sessions throughout much of the state. The goal of these sessions is to hear from Washington families, students, and school staff about concerns they have for school environmental health and safety. The SRP team held these sessions in Yakima, Thurston County, Spokane, and Vancouver. Outreach was conducted through school flyer distribution (Peachjar) and social media. Outreach Videos

Recently, a community group asked the Board to consider updating its hearing screening standards, also known as auditory screening, to include another screening technology. The Board usually shares information about rulemaking through email, website updates, and social media posts. While planning for this project, staff noted that written English and American Sign Language (ASL) are different languages with their own vocabulary and grammar. Communications in written English are not always the most accessible way to reach the Deaf community.



To create more inclusive communications, staff collaborated with a highly qualified Deaf Interpreter (DI) to produce short informational videos in ASL. These videos include details about the project and ways for people who are Deaf or Hard of Hearing to get involved.

These videos (in ASL) are available on the Board's **<u>rulemaking</u>** webpage. Please feel free to share them widely.

The Board conducts <u>Health Impact Reviews</u> (HIRs) in collaboration with the <u>Council</u> on Health Disparities. An HIR is an objective, non-partisan, evidencebased report. It provides the Governor and state Legislators with information about how policy or budgetary proposals may impact health and equity in Washington State.

An HIR can be requested by the Governor or legislators on a proposal related to any policy topic. Our most requested topic areas are healthcare, the criminal and civil legal systems, behavioral health, and education.
