**Purpose:** Chapter 246-760 WAC – Hearing Screening Standards for School Districts. The purpose of this adopted rule is to update the State Board of Health's (Board's) existing hearing screening standards for school districts. These rules establish requirements for annual preventative hearing and vision screenings, including which students are screened, how often, approved tools, referral criteria, procedures, and staff qualifications. The hearing screening sections of the rule were most recently updated in 2002. Since then, the Board has updated the vision screening sections of the rule, and new hearing screening technology and standards have become available. The adopted updates modernize the Board's hearing screening standards, and will help school districts and screening staff improve hearing screening programs while keeping the rules clear and effective.
